GUIDELINES FOR E-TENDERING:-Instructions for Online Bid Submission

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at:https://eprocure.gov.in/eprocure/app.

1. REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / n Code / e Mudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID /password and thepasswordofthe DSC/e-Token.

2. SEARCHINGFORTENDERDOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to searchactivetendersbyseveralparameters. These parameters could include Tender ID, Organiz ation Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPPP or tal.
- 2) Once the bidders have selected the tenders they are interested in, they may downloadthe required documents / tender schedules. These tender scan be moved to the respective My Tenders 'folder. This would enable the CPP Portal to intimate the bidders through SMS/email incase there is any corrigen dumissued to the tender document.
- 3) The biddershould make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Help desk.

3. PREPARATIONOFBIDS

- 1) Bidder should take into account any corrigendum published on the tender documentbeforesubmitting theirbids.
- 2) Pleasegothrough thetenderadvertisementandthe tenderdocumentcarefullytounderstand the documents required to be submitted as part of the bid. Please note thenumber of covers in which the bid documents have to be submitted, the number ofdocuments including the names and content of each of the document that need to besubmitted. Any deviations from the semaylead to rejection of the besubmitted.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR /DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and whiteoption which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documentswhich are required to be submitted as a part of every bid, a provision of uploading suchstandard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) hasbeen provided to the bidders. Bidder scan use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directlysubmitted from the "My Space" area while submitting a bid, and need not be uploadedagain and again. This will lead to a reduction in the time required for bid submissionprocess.

4. SUBMISSIONOFBIDS

- 2) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 3) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 4) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.
- 5) BiddershouldpreparetheEMDaspertheinstructionsspecifiedinthetenderdocument. Theorigi nalshouldbeposted/couriered/giveninpersontotheconcernedofficial, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwiset

heuploaded bidwill berejected.

- 6) The agency shall download the pre bid clarification if any for the work and upload thesame (scanned copy) duly signed and sealed. The revised documents (if any) shall beuploadedin etenderportal.
- 7) Bidders are requested to note that they should necessarily submit their financial bids inthe format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloadedand to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the SKY BLUE coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bidwill be rejected.
- 8) Tenders are advised to upload their documents well in advance, to avoid last minutesrush on the server or complications in uploading. DCSEM, in any case, shall not be heldresponsible for any type of difficulties during uploading the documents including serverandtechnicalproblemswhatsoever.
- 9) Bid documents may be scanned with 100 dpi with black and white option which helps inreducingsize ofthescanned document.
- 10) The server time (which his displayed on the bidders' dash board) will be considered asthestandardtimeforreferencingthedeadlinesforsubmissionofthebidsbythebidders, opening of bids etc. The bidders should follow this time during bid submission.
- 11) Submission of the tender documents after the due date and time (including extended Period) shall not be permitted.
- 12) AllthedocumentsbeingsubmittedbythebidderswouldbeencryptedusingPKlencryption techniques to ensure the secrecy of the data. The data entered cannot beviewed by unauthorized persons until the time of bid opening. The confidentiality of thebids is maintained using the secured Socket Layer 128 bit encryption technology. Datastorage encryption of sensitive fields is done. Any bid document that is uploaded to theserver is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's publickeys. Overall, the uploaded tender documents become readable only after the tenderopening by the authorized bidopeners.
- 13) The uploaded tender documents become readable only after the tender opening by theauthorized bid openers.
- 14) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze BidSubmission" in the portal), the portal will give a successful bid submission message & abid summary will be displayed with the bid no. and the date & time of submission of

- 15) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid openingmeetings.
- 16) Intending Bidders are advised to visit this website regularly till closing date of submission to keep themselves updated as any change/ modification in the tender will be intimated through this website only by corrigendum / addendum/ amendment.

5. ASSISTANCETOBIDDERS

- 1) Any queries relating to the tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.
- 2) Any queries relating to the process of online bid submission or queries relating to CPPPortalingeneralmaybedirectedtothe24x7 CPP Portal Help desk.

The enlistment of the contractors should be valid on the last date of submission of tenders.

In case the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.

- 1. The intending bidder must read the terms and conditions of NIT carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 2. Information and instructions for bidders posted on website/CPP Portal shall form part of bid document.
- 3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website/CPP Portal/www.nia.nic.in free of cost.
- 4. The bid can only be submitted after deposition of original EMD either in the office of Joint Director inviting bids within the period of bid submission. and uploading the mandatory scanned documents such as Banker's Cheque of a Commercial Bank/ Account Payee Demand Draft of a Commercial Bank Fixed Deposit Receipt (FDR) of a Commercial Bank/ Insurance Surety Bonds/ Bank Guarantee (for balance amount as prescribed) from a Commercial Bank towards EMD in favour of *Vice Chancellor NIA*, *Jaipur* receipt of deposition of original EMD and other documents as specified.

- 7. The contractor can upload documents in the form of JPG format and PDF format.

- 8. Contractor must ensure to quote his percentage rate (above/below) on estimated cost in the BOQ /schedule.
- 9. The contractor shall get receipt of deposition of original EMD in the office of Joint Director inviting bids in the prescribed format annexed as **Annexure-I** and also upload it along with the bid document.
- 10. The tenderer should also read the General Conditions of Contract for CPWD Works 2020 amended upto Last Date of Submission of BID (available on CPP Portal & above websites), which is available as Govt. of India Publications.
- 11. Tenders with any condition including that of conditional rebates in the tender document shall be rejected forthwith.
- 12. GST, purchase tax, turn over tax, Excise duty, work contract tax or any other tax as applicable shall be paid by the contractor himself. The contractor shall quote his rates considering all such taxes. The TDS (tax deduction at source) shall be done from bill payments to the contractor as per Government law and rules.
- 13. If any information furnished by the applicant is found incorrect at a later stage, he shall be liable to be debarred from tendering/ taking up of works in NIA. The Department reserves the right to verify the particulars furnished by the applicant independently.
- 14. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
- 15. The tenderer should not have been blacklisted or penalized by any Central Government/State Government Offices/PSUs. A self certificate / declaration in this effect is required to be scanned and uploaded while participation in tendering process.
- 16. The contractor has to follow "Standard Operating Procedures (SOPs) and Guidelines for Construction Site for COVID-19 Outbreak" issued vide DG, CPWD, New Delhi O.M. No. 2/9/2020-WII/DG/169 dated 05.05.2019 and any other Govt. directions in this regard from time to time until the effect of COVID-19. Therefore, it is suggested to go through the above said guidelines before submitting the tender.

17 FINANCIAL EVALUATION:

- (a) The financial bid shall be opened of only those bidders who have been found to be technically eligible.
- (b) Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and total price that is, the unit price shall prevail and the total price shall be corrected by the Institute. If there is a discrepancy between words and figures, the lesser amount shall be considered as valid and interpretation of NIA Jaipur shall be final. If the Supplier does not accept the correction of the errors, his bid shall be rejected.

- (c) The NIA Jaipur does not bind himself to accept the lowest bid or any bid and reserves the right of accepting the whole or any part of the bid or portion of the job offered; and the bidder shall provide the same at the rates quoted. The NIA Jaipur reserves the right to reject any or all offers received in response to tender or cancel or withdraw the tender notice without assigning any reason, whatsoever.
- (d) On opening of Financial Bid of the tender, the work Order will be given to the firm whose overall rates are lowest and the L1 will be decided taking into account for final / total amount
- 18. The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non -judicial stamp paper of Rs. 500/ (Rs. Five Hundred only) along with performance security within fifteen days of the issue of the Letter of notification of a ward. In the event of failure on the part of the successful bidder to sign the Contract within the period stipulated above, the EMD shall be forfeited and the acceptance of BID shall be considered as cancelled.
- 19. As a guarantee towards due performance and compliance of the contract work, the successful bidder (contractor) will deposit an amount equal to 5% of contract value and should be kept valid for a period of 60 days beyond completion of all the contractual obligation, security deposit by way of demand draft in favour of "Vice Chancellor, National Institute of Ayurveda" payable at JAIPUR drawn on any Nationalized Bank/Scheduled Bank within fifteen days of the issue of the Letter of notification of award along with non-judicial stamp paper of Rs. 500/- (Contract agreement).
- 20. Bidder shall submit a copy of the tender document and addenda thereto, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender enquiry document.
- 21. Breach of Terms and Conditions: In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/job without assigning any reason thereof and nothing will be payable by NIA, Jaipur in that event the security deposit shall also stands forfeited.

GENERAL CONDITIONS & SPECIFICATIONS FOR CIVIL WORK

1.0 General Conditions for Civil Works

- 1.1 The work in general shall be carried out in accordance with the CPWD Specifications 2019 Vol. I to II (corrected up to the last date of submission/uploading of bid) hereinafter referred as CPWD Specifications.
- 1.2 **Order of Preference:** In case of any difference or discrepancy between the description of items as given in the schedule of quantities, particular specifications for individual items of work (including special conditions) and I.S. Codes etc., the following order of preference shall be observed:
 - (i) Description of items as given in Schedule of quantities
 - (ii) Particular specifications
 - (iii) Special conditions
 - (iv) Additional condition
 - (v) Tender drawings attached/issued during execution
 - (vi) CPWD Specifications including upto date correction slips.
 - (vii) General Conditions of Contract 2020 for CPWD Works with upto date correction slips.
 - (viii) Indian Standards Specifications of B.I.S.
 - (ix) ASTM, BS, or other foreign origin code mentioned in tender document.
 - (x) Manufacturer's specifications and as decided by the Estate-in-charge.
 - (xi) Sound Engineering practices or well established local construction practices.
- 1.3 The water shall be arranged by contractor at his own cost.
- 1.4 The work shall be carried out in accordance with the Architectural drawings and structural drawings approved by the Estate-in-Charge and as per directions of Estate In-charge. The relevant drawings/ designs must be prepared by the firm and submitted to the Estate-Incharge for approval before execution.
- 1.5 Before commencement of any item of work the agency shall correlate all the relevant architectural and structural drawings, and specifications etc. and satisfy himself that the information available is complete and unambiguous. The agency alone shall be responsible for any loss or damage occurring by the commencement of work based on any erroneous and or incomplete information and no claim whatsoever shall be entertained on this account.
- 1.6 The Agency shall be responsible for the watch and ward / guard of the buildings safety, fittings and fixtures provided by him against pilferage and breakage during the period of installations and thereafter till the building is physically handed over to the department. No extra payment shall be made on this account.

- 1.7 Sample of building materials, fittings and other articles required for execution of work shall be got approved from the Estate-in-charge before use in the work. The quality of samples brought by the agency shall be judged by standards laid down in the relevant CPWD/ BIS specifications. All materials and articles brought by the agency to the site for use shall conform to the samples approved by the Estate-in-charge which shall be preserved till the completion of the work.
- 1.8 BIS marked materials except otherwise specified shall be subjected to quality test at the discretion of the Estate-in-charge besides testing of other materials as per the specifications described for the item/material. Wherever BIS marked materials are brought to the site of work, the agency shall, if required, by the Estate-in-charge, furnish manufacturer's test certificate or test certificate from approved testing laboratory to establish that the material / procured by the agency for incorporation in the work satisfies the provisions of specifications / BIS codes relevant to the material and / or the work done.
- 1.9 Regarding testing of civil & electrical materials, the testing of materials shall be conducted in Govt. Laboratory/ Govt. colleges/ IITs/NITs or from the laboratory as approved by Estate-in-charge. The complete charges of testing of materials in approved laboratory shall be borne by the contractor.
- 2.0 Additional Conditions for Civil Work

2.0.1 General

- 2.0.1.1The bidder shall acquaint himself with the proposed site of work, its approach roads, working space available before quoting his rates.
- 2.0.1.2 No Entry/exit/roads other than specified by the Estate-in-charge for purpose of construction activities will be allowed to be used for construction activity purposes or movement of trucks/lorries/load-carriers and nothing extra/ delay whatsoever will be accounted for on this part.
- 2.0.1.3The agency shall take all necessary precautions to prevent any nuisance or inconvenience to the owners, tenants or occupiers of adjacent properties and to the public in general and to prevent any damage to such properties and any pollution of smoke, streams and water-ways. He shall make good at his cost and to the satisfaction of the Estate-in-charge, any damage to roads, paths, cross drainage works or public or private property whatsoever caused thereon by the agency. All waste or superfluous materials shall be removed by the agency without any reservation entirely to the satisfaction of the Estate-in-charge.
- 2.0.1.4 In the event of any restrictions being imposed by the Security agency, NIA, Traffic or any other authority having jurisdiction in the area on the working or movement of labour /material, the agency shall strictly follow such restrictions and nothing extra shall be payable to the agency on this account. The loss of

- time on this account, if any, shall have to be made up by generating additional resources etc.
- 2.0.1.5 The proposed work is highly prestigious; therefore, quality of work is of paramount importance. Agency shall have to engage well experienced skilled labour to execute the work.
- 2.0.1.6 No payment shall be made for any damage caused by rain, snowfall, flood or any other natural calamity, whatsoever during the execution of the work. The agency shall be fully responsible for any damage to the govt. property and work for which the payment has been advanced to him under the contract and he shall make good the same at his risk and cost. The agency shall be fully responsible for safety and security of his material, T&P, Machinery brought to the site by him.
- 2.0.1.7 The agency shall ensure that no construction leachate (e.g. cement slurry etc.), is allowed to percolate into the ground. Adequate precautions are to be taken to safeguard against this including, reduction of wasteful curing processes, collection, basic filtering and reuse. The agency shall follow requisite measures for collecting drainage water run-off from construction areas and material storage sites and diverting water flow away from such polluted areas. Temporary drainage channels, perimeter dike/swale, etc. shall be constructed to carry the pollutant-laden water directly to the treatment device or facility (municipal sewer line).
- 2.0.1.8The agency shall comply with the safety procedures, norms and guidelines (as applicable) as outlined in the document Part 7 Constructional practices and safety- 2005, National Building code of India, Bureau of Indian Standards. A copy of all pertinent regulations and notices concerning accidents, injury and first-aid shall be prominently exhibited at the work site. Depending upon the scope & nature of work, a person qualified in first-aid shall be available at work site to render and direct first-aid to causalities. A telephone may be provided to first-aid assistant with telephone numbers of the hospitals displayed. Complete reports of all accidents and action taken thereon shall be forwarded to the competent authorities
- 2.0.2 The agency shall ensure the following activities for construction workers safety, among other measures:
 - 2.0.2.1 Guarding all parts of dangerous machinery.
 - 2.0.2.2 Precautionary signs for working on machinery
 - 2.0.2.3 Maintaining hoists and lifts, lifting machines, chains, ropes, and other lifting tackles in good condition.
 - 2.0.2.4 Durable and reusable formwork systems to replace timber formwork and ensure that formwork where used is properly maintained.

- 2.0.2.5 Ensuring that walking surfaces or boards at height are of sound construction and are provided with safety rails or belts.
- 2.0.2.6 Provide protective equipment; helmets etc.
- 2.0.2.7 Provide measures to prevent fires. Fire extinguishers and buckets of sand to be provided in the fire-prone area and elsewhere.
- 2.0.2.8 Provide sufficient and suitable light for working during night time.
- 2.0.3 The agency shall provide for adequate number of garbage bins around the construction site and the workers facilities and will be responsible for the proper utilization of these bins for any solid waste generated during the construction. The agency shall ensure that the site and the workers facilities are kept litter free. Separate bins should be provided for plastic, glass, metal, biological and paper waste and labeled in both Hindi and English with suitable symbols.
- 2.0.4 Agency should spray curing water on concrete structure and shall not allow free flow of water. Concrete structures should be kept covered with thick cloth/gunny bags and water should be sprayed on them. Agency shall do water ponding on all sunken slabs using cement and sand mortar.
- 2.0.5 The Agency shall remove from site all rubbish and debris generated by the Works and keep Works clean and tidy throughout the Contract Period. - 1. For all items of civil; CPWD Specifications 2019 Vol I to Vol II with correction slips uptoLast Date of Submission of BID shall be followed. For the items which are not covered under CPWD specifications; the special conditions/B.I.S. specifications shall apply. In this regard the decision of Estate-in-charge shall be final.
- 2. Wherever any reference is made of any Indian Standards, it shall be taken as reference to the latest edition with all amendments/revision issued there upto the date of receipt of tender.
- 3. Unless otherwise specified, the agreement rates for all items of work of the schedule of quantities are for all heights, depths, leads and lifts involved in the execution of work.
- 4. The contractor shall make his own arrangements for obtaining electric connection for carrying out any maintenance activity and make necessary payment directly to the department concerned.

- 12. Chases, holes & drilling works etc. shall be done using only power operated tools.
- 13. The contractor shall have to carry out the work other than day to day maintenance according to programme given by the Estate-in-charge or his representative. The contractor shall not carry out any work in any building without permission of Estate-in-charge. The contractor shall adhere to this programme failing which he shall be wholly responsible. No claim for idle labour on any account shall be entertained. The contractor shall depute his representative daily to the site of work. His name and signature shall be attested by the contractor for record in the department.
- 14. The quarters/flats and portions of quarters/flats where the work is to be executed on any day shall be got approved from the representative of Estate-in-charge at the site of work. No work shall be carried out in any quarters/flats without the approval of the representative of the Estate-in-charge.
- 15. Any work carried out without the approval of the representative of the Estate-in-charge at the site of work shall be rejected and will not be measured and paid for.
- 16. The material such as paints, varnish, distempers, water proofing cement paint and primers etc. as required shall be of approved brand and manufacturers, and of required shade and conforming in all respects to the relevant I.S. specifications.
