Details of the Evaluation System:

There are two types of evaluation system is in place in this institute.

1. University level

a) Diploma in Ayurvedic Nursing and Pharmacy (DAN & P)

The university conducts final examination in first and final years. The passed candidates proceeds to next year and candidates clearing final year are proceeded to join internship. The university has provision of supplementary examination for candidates failed in one or more subjects. The entire evaluation system of DAN&P courses is given below in tabular form;
