3. Candidates applying for the Teaching Posts should have qualified NTET in case they are not Teachers in any Ayurvedic College and do not possess Teacher Code allotted by NCISM. At the time of Interview, Candidates have to produce NTET Clearance Certificate.
4. As one time relaxation measure, candidates who do not possess the required Post-Graduate Teaching Experience prescribed for the Posts of Professor and Associate Professor, but possessing the 15 Years Teaching Experience in the Subject concerned for the Post of Professor and 10 Years Teaching Experience in the Subject concerned for the Post of Associate Professor, may also apply and they will be considered for the Post. However, such consideration will be subject to assessment of their suitability for the Post. Merely possessing the required Post-Graduate Experience or not does not confer any right on any candidate for selection or appointment.
5. The Upper Age Limit prescribed for the Posts to be filled by Direct Recruitment shall be relaxed by 5 Years in the case of Applicants belonging to SC, ST and applicants working in Central/State Govt., Central/State Govt. Autonomous Bodies; 3 Years for OBC; 10 Years for PH Candidates; and 3 Years over and above the period of service rendered in Defence Service for Ex-Servicemen.
