Monthly Fixed Remuneration for 10 Posts on Outsourcing Basis

Finance Committee instructed that the fixed monthly salary should not exceed the salary being paid by identical institutions like AIIA, Goa and also it should be uniform in NIA Jaipur as well as NIA Panchkula.

No. FC. 10.5To approve Deviation to the tune of Rs. 90,17,818 in the
Construction 2nd Floor and Addition and Alteration of Hospital
Building.

After detailed discussions and consideration, Finance Committee recommended the Deviation of Rs. 90,17,818 for Construction of 2nd Floor and Addition & Alteration of Hospital Building Project. The Finance Committee was informed that the work was awarded to NPCC. The Tender was opened for Rs. 6,09,68,543 (Rs. 5,79,59,296 + PMC Charges) for the works awarded. However, when the work was in progress, there had been some scope of work in the Building due to fail of IPD building Structure and the Agency proposed MNIT vetted and approved Structural Post Tensioned Methodology for Slab and other changes. This additional work was essential from safety point of view and strengthening of the Hospital Building Structure for further Construction, Addition and Alteration. This resulted in the enhancement of the Original Cost to Rs. 6,99,86,360 (including PMC Charges). Thus, a Deviation of Rs. 90,17,818 took place in the Cost of the Project. The total cost of the Project is below the amount sanctioned by Finance Committee in its 2nd Meeting.

Finance Committee recommended to engage Professor of Practice in Department of Rasa Shastra and Bhaishjaya Kalpana under Category-1 and also recommended, in principle, in other Departments of NIA, Deemed to be University in the following categories initially for one year. The number of Professor of Practice, at any point in time, should not exceed 10% of the sanctioned posts. The engagement of Professors of Practice should adhere to Guideline for engaging professor of practice issued by UGC. **The expenditure to be incurred in this regard should be met from the revenue budget of NIA Deemed to be University**.

Category A. Professor of Practice funded by HEIs from their own resources:

- Category 1: Fixed renumeration of 100000/ excluding TA & local logistics as per Standard provision of NIA, Total 12 lakh/ annum
- Category 2: Fixed renumeration of 75000/ excluding TA & local logistics as per Standard provision. of NIA, Total 9 lakh/ annum
- Category B. No financial implication only TA & local logistics as per Standard provision of NIA.

After detailed deliberations, Finance Committee recommended to engage 1 Patent Attorney on the Monthly Fixed Remuneration of Rs. 75,000 on the following Qualification as domain expert for providing services pertaining to IP Identification and Protection, Legal and Regulatory Compliance, Commercialization and Licensing, Documentation and Reporting on intellectual property issues and filing of patents in order to protect research outputs and effective IPR Management.

Qualification: A Degree in Law from a recognized University with domain expertise on intellectual property laws patent filing and all related fields.

Desirable:

- A. Degree in science, engineering, technology, or a related field is desirable, especially for understanding technical aspects of patents and other IP matters.
- B. Registered as a Patent Agent with the Indian Patent Office is highly desirable and at least 6 patents facilitation to his credit.
- c. At least 3 years of professional experience in the field of intellectual property rights, including work related to patents, trademarks, copyrights, and other IP-related services.
- D. Knowledge of *Ayush* systems and genuine interest and passion for traditional knowledge systems, and their protection and promotion through effective IP management.

Smt. Vijay lakshmi Bhardwaj, Director and Shri Abdul Sadiq Khan, Under Secretary, Ministry of Ayush were also present in the Meeting as Special Invitee.

The Vice-Chancellor, NIA Deemed University & Chairman, Finance Committee, NIA Deemed University called this Urgent Meeting of the Finance Committee to seek necessary approval of Finance Committee to the unaudited Annual Accounts for the financial year 2023-24 in order to comply the audit observations.

In the beginning of the Meeting Prof. Sanjeev Sharma, Vice-Chancellor NIA welcomed the Members and explained the background of this urgent FC meeting. With the permission of the chair, the Finance Officer presented the following Agenda Item before the Finance Committee for its decision:

AgendaTo approve the unaudited Annual Accounts for the FinancialItem No. FC 11.1Year 2023-24.

It was apprised that an observation has informally been communicated by the CAG audit team that unaudited Annual Account of NIA Deemed University should be approved by the Finance Committee.

Finance Committee went through the Annual Accounts and suggested that comments from Chartered Accountant on Annaul Account may be obtained and also affixed his signature and seal on the Accounts. While making entries in accounting books bookkeeping principles should be followed. FC also noted that in some heads unexpected change in expenditure have been shown in the statement of accounts. While putting the agenda items for approval to the unaudited accounts from the finance committee such unexpected changes should be explained with full justification.

In this connection, Finance Committee perused and considered the provisions of Rule-16 - Powers and Functions of the Finance Committee of Rules & Regulations of Memorandum of Association of NIA Deemed University which are reproduce below for ready reference:

"16. POWERS AND FUNCTIONS OF THE FINANCE COMMITTEE:

- 16.1 To consider the annual accounts and financial estimates of the Institution Deemed to be University and to submit them to the Board of the Management for its approval;
- 16.2 To consider and recommend the annual budget and revised estimates to the Board of Management;
- 16.3 To fix limits on the total recurring expenditure and the total non-recurring expenditure of each year based on the income and resources of the Institution Deemed to be University.

Note: No expenditure other than that provided in the budget shall be incurred by the Institution Deemed to be University without the approval of the Finance Committee."

After careful consideration of the observations made by the audit and in the light of above provisions of Memorandum of Association, FC approved the Annual Accounts for the year 2023-24 subject to the compliance of earlier audit observations, if any.

The meeting ended with a lot of things to be chair.
