MINUTES OF THE 7TH MEETING OF BOARD OF MANAGEMENT HELD ON 31-1-2024.

Shri BK Singh, Joint Secretary, Ministry of Ayush, could not participate due to pre-occupations.

Board of Management was informed that the Government of Rajasthan has withdrawn their 2 Nominees from the Board of Management and the Institute has already requested the Govt. of Rajasthan for nominating 2 Members in their places.

Prof. Sanjeev Sharma, Chairman, in his Opening Remarks, welcomed the Members and sought their valuable opinions and suggestions for the further development of the Institute. He informed that the Institute has received NABL Accreditation for its Laboratory and the process is going on for continuation of the NABH Accreditation of its Hospital for which Third Party Audit has already been conducted. He also informed that the Recruitments for all the Posts for NIA, Panchkula and that of NIA, Jaipur have been completed and except 5 Candidates, all 40 Candidates selected have joined. An Orientation Training Program was conducted for all the newly recruited personnel, he added. The next recruitments for the remaining vacant Posts are being taken up.

Dr. Narinder Singh, Associate Professor and Joint Registrar(Academic) I/C, then presented the Agenda Items for discussion and consideration:

Agenda Item No. 7.1 To confirm the Minutes of the 6th Meeting of Board of Management held on 20-12-2023.

As there was no observations received on the circulated minutes hence, Board of Management confirmed Minutes of its 6th Meeting held on 20-12-2023.

Agenda Item No. 7.2 To report Action Taken/Present Position on the Minutes of the 6th Meeting of Board of Management.

Board of Management noted the Action Taken/Present Position on the Minutes of its 6th Meeting held on 20-12-2023.



Agenda Item No. 7.3

To ratify the Appointments and Confirmations made to Regular Posts with the Recommendations of Selection Committees and DPCs.

Board of Management ratified the Appointments made by Vice-Chancellor, on behalf of Board of Management, under the Powers vested on him, to the Vacant Regular Posts and also Confirmation of Employees as recommended by the respective Selection Committees and DPCs.

Agenda Item No. 7.4

To change the Nomenclature of the Posts of Joint Director(Admn.), Deputy Director(Admn.) and Administrative Officer in tune with the Nomenclature of Administrative Posts in UGC Pattern.

After detailed discussions, Board of Management approved to change the Nomenclatures of the Posts of Joint Director(Admn.), Deputy Director(Admn.) and Administrative Officer as Joint Registrar(Admn.), Deputy Registrar(Admn.) and Assistant Registrar(Admn.), respectively, in the existing Pay Scales. Board of Management also amended the Provisions accordingly in Col.11 of RRs and also the Composition of Selection Committee/DPC in Col. 12. The Board of Management thus approved the Recruitment Rules for these three Categories of Administrative Posts as attached with the Minutes. It was recommended by Board of Management that copies of the amended Recruitment Rules should be sent to the Ministry of Ayush for information.

Agenda Item No. 7.5

To consider and approve allowing of Designations also along with Pay Scales to Medical Officers and Resident Medical Officer under Approved DACP Scheme.

Board of Management noted that the Ministry of Ayush had extended DACP Scheme in respect of Ayush Doctors (Non-Teaching Staff) working in the National Institutes, like Medical, Clinical, Specialists, Supportive Clinical/Research Staff, vide its OM dated 27-6-2017. This DACP Scheme has already been implemented in the Institute. The Board of Management also noted that under this DACP Scheme, upgradation of only Pay Scales are allowed to the eligible incumbents, unlike the Teaching Cadre, they are deprived of upgraded Designations. After detailed discussions, Board of Management approved, in principle, to allow Designations also along with the upgradation of Pay Scales for all the incumbents working on the Posts specified in the OM dated 27-6-2017 and decided that the details and RRs should be submitted in the next Meeting of Board of Management for approval for these categories.

Agenda Item No. 7.6

To consider amendments in the Recruitment Rules for the Post of Photocopy Operator and bifurcate the Approved RRs for Nursing Officer(Ayurveda) and Nursing Officer(Modern).

Photocopy Operator: The Board of Management noted that the existing Nomenclature of Gestetner Operator is irrelevant in the present day times and that it should be changed as Photocopy Operator for the existing lone Post in this category. After detailed discussions, Board of Management approved to change the Nomenclature of the Post of Gestetner Operator as Photocopy Operator and also approved its RRs, as attached herewith.

Nursing Officer: Board of Management noted that with the clubbed RRs for Nursing Officer for both Ayurveda and Modern Streams, only Modern qualified Nursing Officers, standing in Merits, got recruited in the last three recruitments resulting in dearth of qualified Nursing Officers of Ayurveda/Ayush stream. Board of Management, therefore, approved to bifurcate the RRs separately for Nursing Officer(Ayurveda) and Nursing Officer (Modern), as approved and attached in these Minutes.

This will benefit the Institute to recruit Nursing Officer either in Ayurveda Stream and Modern Stream as per its needs. Board of Management, however, noted that presently, the Institute has not specified the number of Nursing Officers required for Ayurveda and Moden Streams, out of its sanctioned strength. It was, therefore, decided that Vice-Chancellor may constitute an internal Committee to specify the number of Nursing Officers required for Ayurveda and Modern Streams, out of the Sanctioned Strength, and submit the same in the next Meeting for approval.

Agenda Item No. 7.7 Information and approval of the Intellectual Property Rights(IPR) Policy for NIADU.

Board of Management discussed in detail on the Intellectual Property Rights (IPR) Policy. It was informed that the comments and suggestions received from International Federation of Professional Managers (IFPM), Forum on Indian Traditional Medicine (FITM), Invest India, Department of Science & Technology (DST) etc. were considered and incorporated in the IPR Policy. Comments from Council of Scientific & Industrial Research (CSIR) are awaited and on receipt of the same, the comments will be incorporated in the Policy. The suggestions given by Dr. Ranjit Puranik are very important, especially sharing of the revenue and also constitution of a Board and IPR Cell. More attention will be paid on inclusion of industry part also for maintaining transparency. It was decided that any amendments and provisions required in future will be carried out from time to time in the Intellectual Property Rights (IPR) Policy. Board of Management, after the discussions, approved the IPR Policy, in principle.
